Request for Expression of Interest (EOI)

Power Grid Company of Bangladesh Limited (PGCB) will execute Integrated Capacity Development Project in the Power Transmission System of Bangladesh. The objective of this assignment is to engage an individual consultant that will assist PGCB in implementation of the "Integrated Capacity Development Project in the Power Transmission System of Bangladesh" financed by the Republic of Korea EAKPF. The individual consultant will assist Power Grid Company of Bangladesh Limited (PGCB) in determining and organizing the short-term scholarship program for 45 undergraduate university students and also for 45 PGCB engineers. The individual consultant will prepare several reports on the areas of skills/courses, set up selection criteria and procedures to implement the capacity development activities. The individual consultant will help to prepare an evaluation report of the scholarship programs and recommend suggestions to improve them in the subsequent phase.

The consulting services will be financed from Asian Development Bank's (ADB) grant 0590-BAN (EF): Integrated Capacity Development Project in the Power Transmission System of Bangladesh

On the above context, PGCB intends to prepare a shortlist of individual consultants from member countries of ADB.

- The individual consultant will be selected under the Individual Consultancy Services (ICS) procedures following the Guidelines on the Use of Consultants by Asian Development Bank and its Borrowers (2017 as amended from time to time) which can be found at the following website: www.adb.org ADB's Guidelines on the Use of Consultants. The requested Individual Consultant's qualifications, experiences and tasks are outlined in the draft terms of reference (ToR).
- PGCB invites eligible individual consultant to express his interests in providing the above mentioned consulting services. This invitation, the draft ToR and the form of Expression of Interest (EoI) are available at www.pgcb.gov.bd. This information would also be accessible on the ADB website http://cms.adb.org. Interested individual consultant may obtain additional information from the office at the address below during office hours i.e. 0900 to 1700 hours, Sunday to Thursday.
- Interested individual consultant must provide information indicating that he is gualified to perform the services (educational qualification, description of similar assignments, experience in similar conditions etc.). Individual consultant must be experienced of completing similar projects that include Bangladesh power sector and issues like 'gender' and 'social development'. Documentary evidence like completion certificate with scope or contract agreement including scope etc. must be provided for the projects submitted by the individual consultant as his competency in Eol. Individual consultant have to mention the type of organization which are included in his experience of Eol. The Eols would be reviewed on the basis of the following:
 - Educational qualification,
 - Experience, facilities and areas of expertise, b)
 - c) History of Litigation,
 - d) Description of similar assignments (Maximum 15)
 - e) Experience in similar operating conditions,
 - Experience of working in similar geographical area,
 - Other documents as mentioned in detailed EoI document.
