## A. Background information

The Government of the People's Republic of Bangladesh has received a grant of about EURO 15 million from KfW Entwicklungsbank, Frankfurt, the German Development Bank, towards the cost of the above Project, to be implemented by Power Grid Company of Bangladesh Limited (PGCB), the Project Executing Agency (PEA). The estimated total project cost ("Total Cost") underlying the project appraisal is approximately EUR 80.5million. The Loan amount is EUR 45.0 million, the Financial Contribution amount is EUR15.0 million. The project will consist of the following scope divided into six lots:-

- 1) <u>Lot-1:</u>
  - Ishwardi-Rajshahi 230KV D/C T/L; 80KM.
  - Baghabari-Bangura 132KV S/C T/L on D/C Tower; 25KM.
  - LILO of 132KV Rangpur-Palashbari D/C T/L to Mithapukur 132/33 KV Substation; 2KM.

  - Gallamari-Gopalganj 132KV D/C T/L construction; 53KM.
  - LILO of Bheramara-Khulna(S) 230KV D/C to Jhenaidah 230/132/33 KV Substation; 1.5KM.

  - LILO of Bheramara-Faridpur 132KV D/C T/L to Rajbari Substation; 2KM.

## B. The Project

- 1. The Project-Executing Agency (*Item B (2) of this invitation for Eol*) hereby invites <u>qualified independent consultants</u> to submit a prequalification document for consulting services required. Funds have been committed for this project by the German bilateral Financial Cooperation, provided through KfW development bank.
- 2. The project will be promoted by :

- 3. The Project is intended to improve and modernize the **Western Grid Power Transmission Network** through the rehabilitation, replacement and expansion of the existing power transmission by use of efficient and environmental-friendly installations. Project measures are stipulated above under **item A**. The larger objective of the project is to assist in the development of a robust and modern power transmission system operated by in order to sustain the fast growing electricity demand development of Bangladesh.
- 4. The requested services of the consultant shall comprise all relevant professional activities for the supervision of the implementation of the project. The Consulting services shall be performed in Bangladesh over an estimated period of 36 months. The consultant will supervise the whole project during the implementation stage including supply, installation, testing and commissioning up to handing over. The tentative scope of services envisaged comprises also the monitoring of the adherence to environmental and social safeguards principles.
- 5. Services are to be provided by a team comprising of international and local short- & long term experts such as transmission specialist, substation specialist,

SCADA/Telecom specialist, protection specialist, environmental specialist, sociologist, civil works, contractual engineer and other professional and administrative support staff. Efficient management and backstopping services shall be made available. During the implementation of the project, the environmental and social scientist will have to follow the adherence of the contractor(s) to environmental and social requirements.

- 6. Consultants are free to associate themselves with other firms to ensure that all required know-how and experience are available to them.
- 7. The Expression of Interest<sup>1</sup> in English language shall have the following structure and content and shall be presented in the same sequence as shown below:
  - (i) Covering Letter, comprising the firm's name, address, contact person, telephone, fax, email, if applicable mentioning the association for this project. The letter should be on a letterhead of the company or that of authorised lead agency in case of associations and signed by an authorised representative of the company or lead agency.
  - (ii) **Presentations of firms** (maximum 10 pages), inclusive clear statements of type, property and key task of the association, if applicable.

## (iii) Statements and Declarations:

- a) Declaration of submitting a proposal (**letter of Intent**) in case of being short-listed (ref Annex A1);
- b) Statement on **affiliations** (ref Annex A2) of any kind with other firms which may present a conflict of interest in providing the envisaged services (in case of an association one separate declaration for <u>each member</u>).
- c) In case of an **association** (ref Annex A3), the intended contractual arrangement with international and local firms, nominating the lead consultant and including letters of intent of participating firms (in case of local partners, a fax copy of such letter of intent is sufficient).
- d) Declaration of Undertaking (ref Annex A4) to observe the highest standard of ethics during execution of the con-tract. Applicants should be aware that any fraudulent or corrupt activities disqualify them immediately from participation in the selection process and will be subject to further legal investigation. Declarations stated here below must be signed with legal effect by sufficiently authorised representatives of the bidder, and in the case of joint bids by <u>all partners</u>. Failure to submit the Declarations or to comply with the requirements contained in it shall lead to exclusion from the tender process.
- e) Statement about Quality Control Management and copy of a Certificate giving evidence of the lead consultant's quality management capacities.

- (iv) **List of project references** carried out as <u>Annex B</u> covering the recent 5 years and strictly related to the envisaged services (maximum 5 references each, neatly separated from each other, by preference through chapter registers).
  - An outline of the firm's and its associates' (if any) recent experience related to <u>HV Transmission Line works (line & substations) of a voltage level of 132</u> <u>kV and 230 kV (at least 2 projects at 220kV or 230 kV level).</u>
  - an outline of the firm's and its associates' (if any) recent (5 years) experience on having <u>conducted or supervised ESIA</u>, <u>ESMP and RAP-</u> works for transmission systems.
- (v) Brief CVs and structure on personnel proposed for <u>backstopping and home</u> <u>office support</u> (shall not be confused with the project team). A list of envisaged backstopping staff with their specialities shall precede the CVs.
- (vi) List of available personnel structure for the envisaged services with information about education, professional experience, regional experience, years with firm, specific project-related experience and experience in similar posts. This list shall allow a profound judgement on the consultants' general ability to provide the required personnel having the specific experience for the project in case of an offer. Personal belongs to the firm or have a long cooperation gets more points.

Interested consultants are requested to submit concise and clear, but substantial documents and to adhere to the above structure. Non-compliance with this invitation or faulty information shall lead to non-qualification. Any surplus of information not specific to the material requested will be penalized. A clear document structure is considered as a plus.

The prequalification proposal shall be submitted in one (1) printed original N° 1 and two
(2) printed copies as well as an electronic copy either on a CDROM or a USB-key to the PEA, with the address given below, latest by 28<sup>th</sup> September, 2016, time: before the end of official business hours, and/or as indicated in the advertisement.

- 10. All cost for a site visit, obtaining information/data and preparation/submission of the prequalification document, meetings, negotiations, etc. in relation with the prequalification or the subsequent proposal shall be borne by the consultants.
- 11. At any time, PEA either at its own initiative or in response to clarifications requested by an interested consultant may <u>clarify</u> this invitation. Such information shall be sent in writing by <u>e-mail</u> to all parties, which have informed PEA and the Tender Agent about their participation. Any clarification regarding this Expression of Interest shall be addressed to both, the Project Executing Agency and the Tender Agent whose addresses are stated above.
- 12. The evaluation procedure for the prequalification process will follow the latest version of the "Guidelines for Assignment of Consultants in Financial Co-operation Projects"(refer to homepage of KfW Development Bank: <u>https://www.kfw-entwicklungsbank.de/Download-Center/PDF-Dokumente-Richtlinien/Consulting-E.pdf</u>). - 13. After having completed the evaluation of the prequalification documents, a short-list consisting of five (5) highest ranked consultants scoring a minimum of <u>70 points</u> will be established. If more than five bidders achieve that total, the five with the highest number of points will be selected. Short-listed firms will be invited to submit a technical and financial proposal; firms not pre-qualified will be informed accordingly.
- 14. PEA is <u>not bound</u> to select any consultant.
- 15. The preparation and the submission of the prequalification document is the responsibility of the applicant and no relief or consideration can be given for errors and omissions.
- 16. After opening the prequalification documents until preparation of the short-list of the qualified consultants, no communication of any type shall be entertained unless called for by PEA.
